All Commissioners are in today. A staff meeting was held and present were Pat Dringman, Cory Conner, Page Dringman, Connie Weston, Barb Swanson, Marc King, Cliff Brophy, Kris Novotny, Susan Metcalf, Alan Ronneberg and Jessie Connolly.

Superintendent of Schools Metcalf informed us that there are 9 school board positions around the county that are up this year, the hearing against the high school board is wrapping up, there is the clerk position and superintendent position at the high school that are open and the county spelling be will be February 26, 2020.

Fire Chief Novotny reported that the DNRC is staffing local offices for wind events and will continue this policy thru the summer and the fire department will be offering a heavy equipment operator training on February 13, 2020.
