Monday, March 2, 2020

All Commissioners are in today.

A staff meeting was held. Present were Cliff Brophy, Char Fuller, Connie Weston, Pat Dringman, Alan Ronneberg, Page Dringman, Marc King, Jessie Connolly, Vera Pederson, Cory Conner, Susan Metcalf, Vicki Uehling and Barb Swanson.

Sheriff Ronneberg reported the numbers for the month and stated he hired a new dispatcher, completed the COPS grant and is working on the STEP grant.

DES/911 Coordinator Brophy said he has been busy with the grant season and asking for letters of support.

Superintendent of Schools Metcalf said they had a 4th grade student win the spelling bee this year and that the high school will have a trustee election with 5 people running for 2 board positions, Melville has a contested trustee race and that BTGS will be having a mill levy election.

Public Works Director Conner said his department had been out on Berg Lane working on shaling and crushing and also touched up Cremer Road.

County Planner Dringman said the growth policy will need updated this year, the city council is looking at subdivision regulations and they received the draft of the Custer/Gallatin Forest Revision Plan.

Extension Agent King said he took the judging team to Miles City, held an estate planning workshop last month and attended the meeting to score the job descriptions.

Clerk of Court Swanson reported the numbers for the month and said they will have 2 bench trials this month.

Weed Coordinator Weston said she turned in the RAC grant, has a trust fund presentation this week in Helena and scheduled the Weed Summit for April 28th.

Treasurer Fuller said that February was slow and she sent out reminders about delinquent taxes.

Justice of Peace Connolly reported the numbers for the month, said she attended Alternatives, Commission on Courts of Limited Jurisdiction, salary scoring and high school board meetings.

Finance Officer Uehling said she has been helping with grants, job scoring meeting and the procurement policy.

County Attorney Dringman said court has been busy, training in April and meeting with Park County regarding the proposed drug court.

Clerk and Recorder Pederson informed us that the deadlines for filing for the upcoming primary election is March 9, 2020 and for the school trustee election is March 26, 2020. She said she attended election training in Great Falls and that she will be getting a grant for new voting equipment.
