Monday, July 6, 2020

All Commissioners are in today.

A staff meeting was held at the Extension Conference room. Present were Cliff Brophy, Susan Metcalf, Barb Swanson, Marc King, Connie Weston, Vicki Uehling, Alan Ronneberg, Jessie Connolly and Vera Pederson.

DES/911 Coordinator Brophy discussed the EMPG grant and gave an update on the masks that he received.

Finance Officer Uehling said she has been busy with budgets and end of year items.

Justice of the Peace Connolly reported the numbers for the month, said she attended an Alternatives quarterly meeting, Commission on Courts of Limited Jurisdiction, and Mental Health Board meeting.

Superintendent of Schools Metcalf said she has been working with the schools on the reopening plans and will be having a transportation board meeting to discuss the bus routes for the year.
