Minutes for the Meeting on May 27, 2021 were approved as submitted.

Welcome and self-introductions

Local Emergency Planning Committee (L.E.P.C.) Topics:

Matt spoke about the events planned for this Thursday the 24th. Sibanye – Stillwater Mine will host a virtual public meeting open to present the Tailings Storage Facility emergency preparedness plan. This will begin at 9:00 am on Thursday. The mine officials will provide a power point presentation explaining the emergency preparedness plan. Local officials are invited to speak and answer questions about the county's procedure for evacuations and emergency notifications. After the virtual meeting, mine officials and local officials will meet with a group of residents that reside in the immediate area of the mine. This will take place at the McLeod Fire Hall.

Disaster and Emergency Services (D.E.S.) Topics:

Cliff Brophy announced that the updates to the County/City Emergency Operations
Plans (EOP) were completed. Updates included the following:

(1) Update Contact Information; (2) Annex 16.2.1.2) replaced "channel 3" with "SGC West"; (3) Reformat #22 Plan; (4) Add annexes to Public Health PLAN #22 and renumber all (those annexes added are: 14-Emergency Med. 15-Countermeasures; Chempack Plan; 16-Specimen Transport; 17-Continuity of Opps. Plan; 18-Non-Pharm. Interventions).

If these changes are accepted by the LEPC, then the EOP will be forwarded to the City Council and the County Commissioners for their approval. After that, the plan is sent to the State of MT for Review.

Chief Kris Novotny made a motion to accept the EOP as presented and forward it to the Commissioners and City Council with the recommendation to approve the EOP. Cory Conner seconded. Motion passed unanimously.

Public Health Topics:

Jenn reported that she had previously emailed annex 14 of the County Public Health Plan to appropriate agencies. She indicated that it was reviewed to her satisfaction and she just needed a few more signatures to complete that process.

Fire Topics:

Kris reported that he has had the station staffed since last week. He has been in contact with DNRC.

Public Works:

Corey reported that he has been preparing his water tenders in anticipation of the fire season. Most of the equipment will be centrally located if needed.
