Commissioner Moody and Roe are in today and Commissioner Wallace is helping with the road department.

Finance Officer Uehling and Cindy Selensky were in to go over the fair budget.

County Attorney Dringman gave an update on the Walla trial and said he is on the committee to find a treatment court coordinator.
