WHEREAS, the residents of Sweet Grass County have great respect, admiration, and the utmost gratitude for all of the men and women who have selflessly served our country and this community in the Armed Forces: and

WHEREAS, the contributions and sacrifices of the men and women who served in the Armed Forces have been vital in maintaining the freedoms and way of life enjoyed by our citizens; and

WHEREAS, Sweet Grass County seeks to honor these individuals who have paid the high price for freedom by placing themselves in harm's way for the good of all; and
