#### **RESOLUTION 10-27-2022**

### A RESOLUTION REQUESTING AUTHORITY FOR DISTRIBUTION OF COUNTY MINIMUM ALLOCATION GRANTS FOR WATER AND SEWER INFRASTRUCTURE PROJECTS

WHEREAS, Section 4 of Chapter 401 of the Montana Session Laws of 2021 through House Bill 632 Section 4 allocated the amount of \$150 million of the coronavirus state fiscal recovery funds to be used to provide minimum allocation grants for water and sewer infrastructure projects eligible for funding under the American Rescue Plan;

WHEREAS, the amount a local government is eligible to receive in water and sewer infrastructure grants under this section is in the same proportion and using the same ratios provided for in 15-70-101 (2)(b), (2)(c), and (3) giving County a minimum allocation of \$434,934;

WHEREAS, HB 632 Section 4 requires that a local government, submit an application for a qualifying water or sewer infrastructure project that complies with the uses authorized for the coronavirus state and fiscal funds and pledge matching funds;

WHEREAS, Montana's counties do not generally own or operate water and sewer infrastructure;

WHEREAS, grant funds must be applied for by November 1, 2022 and awarded or in a pending status by January 1, 2023;


WHEREAS, because counties generally do not own water and sewer infrastructure, HB 632 Section 4 allocated grant funds for qualifying water or sewer infrastructure projects within the counties for which it was allocated, but that any local government eligible to receive minimum allocation funds under HB 632 Section 4 could apply for and pledge matching funds for the county's proportion;

WHEREAS, the City of Big Timber is a local government as defined in HB 632 Section 4 and has committed to request the funds by November 1, 2022, if the county's allocation made eligible to them and the county has determined this to be a priority use of the allocated funds.

### THEREFORE, NOW BE IT RESOLVED THAT:

- 1. County has determined that the proposed Big Timber Phase 2 Water System Improvements Project is eligible as a minimum allocation project and is a high priority within the county and;
- 2. By this resolution, Sweet Grass County requests the Department of Natural Resources and Conservation allow, through its developed application and distribution processes, the City of Big Timber \$434,934 of its share of the allocated Minimum Allocation funds for the Phase 2 Water System Improvements Project.

Dear ARPA Team,

The purpose of this letter is to Transfer and Commit Sweet Grass County's ARPA Minimum Allocation Grant funds to the City of Big Timber's water system project.

The County's original Commitment of Funds, and Resolution, submitted with the City of Big Timber's - Phase 2 Water Systems Improvements project, has been re-committed to the new, City of Big Timber Phase 2 Water System Improvements project. The City's original Competitive grant application was unsuccessful, causing the original ARPA Minimum Allocation Grant to be declined. However, the project has been modified and the City is submitting a new ARPA Minimum Allocation Grant. The County has agreed to transfer the previously committed funds to the new project.

Sweet Grass County has committed all of its Minimum Allocation Grant funds (\$434,934.00) created by Montana House Bill 632 and 25% of the Direct Allocation from the Department of Treasury Local Fiscal Recovery Fund (\$181,467.00) for the pending water system improvements project. The total fiscal commitment is \$616,401.00. This action was voted on and approved by the Sweet Grass County Board of Commissioners.

This is approved under the condition that the City of Big Timber will use the committed funds following the administration rules of the American Recovery Rescue Plan Act of 2021.
