### AUGUST 14 - 18, 2023 COMMISSIONER MEETINGS

Sweet Grass County Commissioner meetings are held in the office of the county commissioners in the Sweet Grass County Annex in Big Timber, Montana, unless otherwise noted in the minutes. The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

### Monday, August 14, 2023

All Commissioners are in.

Budget discussions continue with all Commissioners and Finance Officer Vicki Uehling.

Commissioner Moody called the meeting to order for the reading of bids for the Grey Cliff/Voges Bridge Abutment Scour Repair Project. Brandon Duffey with Great West Engineering was present, and Tristen Donnes was also present. The bids were opened at 10:00 AM.

Bid # 1 – Broadwater Excavating – Bid Bond enclosed and addendum was acknowledged. Base bid was \$316,000.00.

Bid # 2 – Donnes Inc. – Bid Bond enclosed and addendum was acknowledged. Base bid was \$434,000.00.

 $Bid\,\#\,3-JAG\,LLC$  (Jason Long) –  $Bid\,Bond$  enclosed and addendum was acknowledged. Base  $Bid\,was\,\$817,\!405.00.$ 

Commissioner Wallace moved to have Great West review and then make a recommendation to the Commission for award. Commissioner Roe seconded and the motion carried with 3 ayes. The meeting was adjourned.

A resident complained about not being notified that the county was going to access a headgate through their property. Public Works Director was notified to please advise prior to accessing.

A resident complained about people speeding, lack of signs and lack of law enforcement presence on Rapelje Road.

Budget discussions continued with various scenarios being presented and multiple mills being applied. The impacts of market assessment, lower Sibanye Stillwater Mine gross proceeds and slightly higher newly taxable properties continue to create a tax shift between entities with the burden being moved to residential.

The County Planner stopped in to discuss her concerns about some boundary relocations and surveys intentionally or unintentionally bypassing the subdivision rules.

### Tuesday, August 15, 2023

All Commissioners are in.

Commissioner Roe attended the Senior Center board meeting.

Commissioner Moody and the County Attorney attended the McLeod School Board Meeting at McLeod.

Commissioner Wallace and Public Works Director Conner went out to Dry Creek Road to look at a cattleguard and the placement of the adjacent gate.

Amber Blake of Catalyst for Change came in to visit with the Commission.

### Wednesday, August 16, 2023

Commissioners Wallace and Roe are in. Commissioner Moody is out.

Finance Officer Uehling came in and the Commissioners worked on the non-levied funds for the budget.

Claims were reviewed and signed.

### Thursday, August 17, 2023

All Commissioners are in.

County Planner Dringman presented a COS for review. The COS was to create a tract of land to provide security for mortgage loan purposes. Commissioner Roe moved to approve the COS as presented by the Planner for Brad and Paige Bichler. Commissioner Wallace seconded and the motion carried with 3 ayes.

Finance Officer Uehling, Treasurer Rasnick, Clerk and Recorder Pederson, along with the Commissioners held a cash meeting to review the end of the year balances within each expenditure and revenue budget, review end of year budget resolutions, the cash report, journal entries etc.

Commissioner Roe moved to adopt Resolution 08-17-2023A. A resolution to amend Fund 2220 (Library). The Amendment will increase the expenditures to reflect unbudgeted revenues of \$3,780.00, not included in the original expenditure budget for 2022-2023. Commissioner Wallace seconded and the motion carried with 3 ayes.

Commissioner Wallace moved to adopt Resolution 08-17-2023B. A resolution to amend Fund 2969 (Opioid Settlement Fund) to reflect the actual dollar amount awarded as part of the national lawsuit. Both the revenue and expenditure funds will be amended by \$4,277.00. Commissioner Roe seconded and the motion carried with 3 ayes.

Commissioner Wallace moved to adopt Resolution 08-17-2023C. A resolution to amend Fund 2979 (Community Services Directory). This fund was created through a donation from the Sweet Grass Community Foundation. Both the revenue and expenditure funds will be amended by \$15,000.00. The motion was seconded by Commissioner Roe and carried with 3 ayes.

Commissioner Wallace moved to adopt Resolution 08-17-2023D to create Fund 2998 (Local Assistance and Tribal Consistency Fund – LATCF). This fund, both expenditure and revenue, was created to reflect the acceptance of funds from the US Department of the Treasury – American Rescue Plan, for a total of \$235,193.00. Commissioner Roe seconded and the motion carried with 3 ayes.

Commissioner Roe moved to adopt Resolution 08-17-2023E. A resolution to authorize a temporary loan, bearing no interest, of unrestricted money from other accounting entries, to be paid back within one year and so recorded. The loan will be from Fund 2900 (PILT) to:

Fund 2220 – Library - \$250.78 – did not mill enough to cover levy.

Fund 2840 – Weed – North Grant - \$4,154.30 – Grant requires expenditure prior to reimbursement.

Fund 2928 – Homeland Security 2022 – \$52,520 – Grant requires expenditure prior to reimbursement.

Fund 2992 – CHW Grant Program - \$4,527.64 – Grant requires expenditure prior to reimbursement.

Fund 2993 – Telehealth Grant - \$126.55 – Grant requires expenditure prior to reimbursement.

A one-time loan will be made from Fund 2900 to the above-mentioned funds for a total of \$61,579.27. This loan will be repaid to Fund 2900 before June 30, 2024.

The motion was seconded by Commissioner Wallace and carried with 3 ayes.

Commissioner Roe moved to accept the adjusting general entries from 632 to 1068, not all inclusive. Commissioner Wallace seconded and the motion carried with 3 ayes.

County Sanitarian Kaleb Pearson stopped in to introduce the new Sanitarian – Scott.

### Friday, August 18, 2023

Commissioners Moody and Roe are in. Commissioner Wallace is out.

Finance Officer Uehling stopped in to drop off some additional scenarios and impacts for various mill levies.

A resident stopped in to ask for support on an access road logging project in the Crazy Mountains. He was referred to the Conservation District as well.

Triangle Telephone called to set up an appointment to cut over the fiber.
