# A RESOLUTION TO ALLOW THE FINANCIAL OFFICER OR THE CLERK & RECORDER TO MAKE BUDGET AMENDMENTS

WHEREAS, Montana Code Annotated 7-6-4006(4), gives the governing body the authority to amend budgets during the fiscal year by conducting hearings at regularly scheduled meetings, and

WHEREAS, circumstances have occurred that require a budget amendment to be made, and

WHEREAS, a meeting that was properly noticed 48 hours in advance and open to the public and was attended by Commissioners Wallace, Moody and Roe, Financial Officer Uehling, Treasurer Rasnick, and Clerk & Recorder Pederson, was held on the 19<sup>th</sup> day of December, 2022 and to amend the expenditure budget of Fund 4420 – CIP Cares, was fully discussed.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Sweet Grass County authorize Financial Officer Vicki Uehling to amend the expenditure budget Fund 4420 in FY 2621-2022. During the budgeting process for FY 2022 an oversight occurred where we did not budget the cash from this fund. It was received in FY 2021. The expenditure budget requires an amendment of \$516,441. Funds from this expenditure budget amendment are from unbudgeted cash.
