The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

All Commissioners are in today.

Commissioner Wallace made a motion to appoint Commissioner Moody as the new chairman. Commissioner Roe seconded this and the motion passed with 3 ayes.

Resolutions for the new year were reviewed and read. (See attached)

Resolution 01-03-2023C – A resolution to set reimbursement for mileage and lodging for Sweet Grass County employees.

Resolution 01-03-2023D – A resolution to establish reimbursement rate for meals for Sweet Grass County employees.

Resolution 01-03-2023E – A resolution establishing a location for posting public notices. Resolution 01-03-2023F – A resolution setting the daily rate for payment of costs for use of the detention center.

Resolution 01-03-2023G – A resolution clarifying the salary for the Superintendent of Schools.

Commissioner Wallace made a motion to approve the resolutions 01-03-2023 A -01-03-2023G. Commissioner Roe seconded this and the motion passed with 3 ayes.

A department head meeting was held with Pat Dringman, Vicki Uehling, Alan Ronneberg, Connie Weston, Cory Conner, Marc King, Cliff Brophy, Vera Pederson, Page Dringman, Char Rasnick and Jessie Connolly present.

Finance Officer Uehling stated the auditor was here last month and that she was working on the annual report that is due today.

County Attorney Dringman said he has been working on the lawsuit regarding Microwave Tower road and several felonies.

Sheriff Ronneberg reported the numbers for the month and said he will be seeking another dispatcher.

Treasurer Rasnick said her office was busy last month with tax collections.

Weed Coordinator Weston said she is slow this time of year and completed the state reports.

Judge Connolly reported the numbers for the month and ready for the legislative session with several bills they will be following.

Superintendent of Schools Rech was welcomed to the meeting and then stated that she will be starting with the school elections and spelling bee.

Planner Dringman said Lana is working on the rural addressing, the growth policy is done and they will be holding public meetings on that and she will be watching the legislative session for several bills.

Public Works Director Conner reported his department was busy with November and December snowstorms and helping replace the Tronrud bridge.

Extension Agent King said he had two judging contests in December, helping with the search for a new extension agent in Carbon County, judged a show in Canada and the Stockgrowers will be hosting a seminar at the fairgrounds January 11th with Dr. Katie and Stella the cow.

DES/911 Coordinator Brophy said he has been dealing with equipment issues.

Clerk and Recorder Pederson reported the November general election was good with no issues, she attended the MACo Elected Officials Training in Helena, she will be watching a lot of the legislative session as there are over 400 proposed election bills. She also stated that the deed recording numbers have dropped a little over the last 2 years.

Commissioner Roe stated they received \$235,192.79 from the Local Assistance and Tribal Consistency Fund, they are continuing to work on the capital improvement plan, attended the senior center board meeting and Beartooth RC & D meeting.

Commissioner Wallace said he attended the PMC board meeting and MACo executive board meeting.

Commissioner Moody added that they signed the new year resolutions, they are working on getting the tank behind the courthouse removed, will be appointing new board members, helped the road department with the Tronrud bridge, attended a fair board and HRDC board meetings.

Commissioner Moody swore in Patrick Dringman for another term as Sweet Grass County Attorney.

Public Works Director Conner presented encroachment permits for approval.

WHEREAS, 7-4-102, M.C.A., gives the Board of County commissioners the authority to establish hours for county offices to be open and transact business, and

WHEREAS, it is the intent of the elected officials and the employees of Sweet Grass County to be available and serve the citizens of Sweet Grass County to the best of their ability.

A RESOLUTION TO SET REIMBURSEMENT FOR MILEAGE AND LODGING

. FOR SWEET GRASS COUNTY EMPLOYEES.

WHEREAS, per 2-18-501, M.C.A. all elected officials, appointed members of boards, commissioners, department heads, and all other county employees must be reimbursed for travel and lodging while away from the person's designated headquarters and engaged in official county business, and

WHEREAS, all travel and lodging must be authorized and approved by county department heads or the Board of County Commissioners prior to the event, and

WHEREAS, all requests for mileage and lodging must be accompanied by receipts and or a mileage log and an agenda for the meeting or proof of registration for a conference prior to the claim being paid.

NOW THEREFORE BE IT RESOLVED that effective January 1, 2023, the reimbursement rate for mileage is \$0.655 per mile. The State rate for lodging is \$98.00 plus tax per night. If the conference or event that the employee is attending is at an establishment that charges a higher rate the county will reimburse at the higher rate if a receipt and copy of the registration and the agenda for the event accompanies the claim.

RESOLUTION NO. 01-03-2023-D

A RESOLUTION TO ESTABLISH REIMBURSEMENT RATES FOR MEALS FOR COUNTY EMPLOYEES.

WHEREAS, all elected officials, appointed members of boards, commissioners, department heads, and other county employees must be reimbursed for meals and lodging while away from the person's designated headquarters and engaged in official county business, pursuant to 2-18-501, MCA, and

WHEREAS, 2-18-502. Computation of meal allowance. (1) Except as provided in subsections (2) and (4), an employee is eligible for the meal allowance provided in 2-18-501, only if the employee is in a travel status for more than 3 continuous hours during the following hours:

- (a) for the morning meal allowance, between the hours of 12:01 a.m. and 10 a.m.;
- (b) for the midday meal allowance, between the hours of 10:01 a.m. and 3 p.m.; and
- (c) for the evening meal allowance, between the hours of 3:01 p.m. and 12 midnight.
- (2) An eligible employee may receive:
- (a) only one of the three meal allowances provided, if the travel was performed within the employee's assigned travel shift; or
- (b) a maximum of two meal allowances if the travel begins before or was completed after the employee's assigned travel shift and the travel did not exceed 24 hours.
- (3) "Travel shift" is that period of time beginning 1 hour before and terminating 1 hour after the employee's normally assigned work shift.
- (4) An appointed member of a state board, commission, or council or a member of a legislative subcommittee or select or interim committee is entitled to a midday meal allowance on a day the individual is attending a meeting of the board, commission, council, or committee, regardless of proximity of the meeting place to the individual's residence or headquarters. This subsection does not apply to a member of a legislative committee during a legislative session.
- (5) The department of administration shall prescribe policies necessary to effectively administer this section for state government.

NOW THEREFORE BE IT RESOLVED, that Sweet Grass County will reimburse the actual cost of the meals if a receipt is presented and the cost is reasonable; however, the total for any one day is \$54.00, which is the current rate per the U.S. General Service Administration effective January 10, 2020. If no receipt is presented employees will be reimbursed at \$13.00 for breakfast, \$15.00 for lunch and \$26.00 for dinner. Employees will not be reimbursed for meals that are provided with the conference or meeting being attended. Sweet Grass County does not reimburse for alcoholic beverages or tips. The Commissioners and the financial officer review all expenditures prior to payment and abuse of this policy will be addressed on an individual basis.
