Sweet Grass County Commissioner meetings are held in the office of the county commissioners in the Sweet Grass County Annex in Big Timber, Montana, unless otherwise noted in the minutes. The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

Monday, July 24, 2023

All Commissioners are in.

Finance Officer Vicki Uehling and the Commissioners discussed the non-levied fund budgets. Commissioners agreed to wait and review the Capital Improvement Budgets prior to making changes until we get the final numbers from the Assessor.

Chairman Moody called the Commission to order for the purpose of discussing the county contribution to the city budget. Commissioner Roe moved to contribute \$16,434.00 to the Fire Administrator Budget. Commissioner Wallace seconded and the motion carried with 3 ayes.

Commissioner Roe moved to contribute \$91,235.00 (50%) to the city for the library budget. Commissioner Wallace seconded and the motion carried with 3 ayes. There was no public present.

Tuesday, July 25, 2023

Commissioners Moody and Wallace are in. Commissioner Roe was in after lunch.

City Councilman stopped in to discuss whether or not the county would be able to help out the city with some tax dollars for the parks.

Wednesday, July 26, 2023

Commissioner Moody is in the office and Commissioner Wallace is helping with the East Boulder bridge replacement at MM 5.16. Commissioner Roe is out.

Finance Officer Uehling was in to drop off insurance numbers for the budget.

A County Resident complained about Bainter Road being very rough.

Thursday, July 27, 2023

Commissioners Moody, Wallace and Roe are in today.

Claims were presented for review.

Finance Officer Uehling and Treasurer Rasnick were in to discuss the cut over to the new server. Apparently, Tyler and Granite will require more than one day to perform the change over.

Mountain Alarm called us back regarding the low battery signal we have been receiving for weeks. We told them to go ahead and disconnect/disregard that signal as we don't know what it goes to.

A county resident called to request assistance with getting the proper signage on the bridge over the West Boulder at McLeod, repairs on the road between the Highway and the bridge at McLeod, a speed limit sign between the highway and the bridge at McLeod and a stop sign at a private driveway that enters the road between the highway and the bridge at McLeod. He also stated that he felt the telephone company subcontractors would disregard any signage on the bridge and use it anyway.

Friday, July 28, 2023

Commissioner Roe is in. Commissioners Wallace and Moody are out.

Received the information from MT DEQ for Hazardous Waste Generator (oil car tanker), it was forwarded to Waste Management. The date we may start is August 26, 2023.
