Monday, June 12, 2023

Commissioner Roe and Wallace are in. Commissioner Moody was summoned for jury duty.

Tim McNew with the Army Corps of Engineers came to look at the Boulder Bridge on Big Timber Loop Road east of town.

Weed Supervisor Weston presented her 2023/2024 budget.

Lana King from the planning office presented the budget for Junk Vehicles.

All Commissioners reviewed the 2023/2024 budget for Mental Health and Alcohol.

Public Works Director Conner brought in an encroachment permit for fiber-optic boring on 85 Lower Deer Creek Road for Triangle Telephone.
