Monday, June 5, 2023

All Commissioners are in today.

A department head meeting was held with Vera Pederson, Connie Weston, Cliff Brophy, Vicki Uehling, Marc King, Barb Swanson, Jessie Connolly and Char Rasnick present.

Extension Agent King said he attended the weed summit and weed board meeting, quality assurance with the 4H kids, unloaded wool from Eastern Montana and went to Texas with the judging team.

Finance Officer Uehling reported that she has been working on budgets and some credit card fraud.

Weed Coordinator Weston has been busy with meetings and the weed summit, went to Dailey Lake and the spray crew started.

Justice of the Peace Connolly reported the numbers for the month and said she attended the Mental Health Advisory Board meeting and CPT meeting.
