At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

Monday, March 6, 2023

All Commissioners are in today.

A staff meeting was held with Callie Rech, Connie Weston, Vicki Uehling, Barb Swanson, Jessie Connolly, Cory Conner, Cliff Brophy, Alan Ronneberg and Vera Pederson present.

Superintendent of Schools Rech said she attended the new superintendent training in Helena last week, spelling bee was last month and state teacher evaluations.

Weed Coordinator Weston said she attended the NWCI meeting by zoom, conservation district meeting, weed board meeting and working on the weed summit.

Finance Officer Uehling said they had a cash meeting last month and some credit card fraud has been happening.

Clerk of District Court Swanson said she hired Amy Krum, reported the numbers for the month and is working on four jury trials coming up.

Sheriff Ronneberg reported the numbers for the month, held a meeting regarding road closures, sent two deputies to Bozeman for narcotics training and one will be going to the National Narcotics Officers Association training, training deputies on warrants for Facebook, Instagram, Snapchat, etc.

Clerk and Recorder Pederson said she is preparing for the upcoming school elections, attending a lot of legislative sessions mainly regarding elections.
