The first Monday of each month a department head staff meeting will be held at 9:30 a.m. Claims will be reviewed and approved for payment every Thursday unless a conflict arises. At least one commissioner will be in the office from 9:00 a.m. to 5:00 p.m. daily unless they are at a conference or a meeting requiring them to be out of the office.

Monday, January 8, 2024

All Commissioners are in.

A county resident stopped in to complain about the speed that deputies are driving when responding to calls east of town through the 45 mph zone on Big Timber Loop Road.

Commissioner Roe moved to appoint the following interested parties to the various boards that have vacancies: Tax Appeal Board – Mike Gregorich and Matt Kleinsasser, Monte Koch and Julie Johnson.; Salary Compensation – Mary Gregorich will be reappointed and Clerk & Recorder Curry will be a new appointee; Airport Board – Bill Keil agreed to be re-appointed and the City will need to do their appointments; Cemetery Board – new appointments – Julie Dodge and Kelly Odron; Fair Board – Re-appoint Cindy Selensky and Austin Standley; Weed Board – Re-appoint Clayr Alexander and Ron Hoagland; County Planning Board – Re-appoint Marc King, Wyatt Donald, and Linda Burch; City/County Planning Board – Re-appoint Brian Engle and Leo Cremer, and new appointee Peter Fox who will take Vera Pederson's place.
